## **2026 Membership Policies**

- **Booking Privileges.** As a member, booking privileges allow you to book 8 days in advance as of 5pm. Tee times can be booked online or by phone.
- **Cancellation/No-Show Policy.** The club requires adequate notice for the cancellation of tee times, and a valid credit card on file for all members.
  - Please note that should you decide to cancel your reservation, whether for your entire reservation or for parts of your reservation, a reasonable notice of 5 hours, during regular operating hours for the pro shop, is allowed. Any cancellations with less than 5 hours' notice during our regular operating hours will be charged to your credit card. A valid credit card number is required on the Chronogolf Account profile of the member.
  - The same would apply for NO-SHOWS, if you do not advise us a minimum of 5 hours in advance of a person or persons that are not playing in your group; they will be charged for their reservation(s).
  - In the case of inclement weather, we will offer more leniency in regards to this policy.
  - Less than 24 hours prior to your reservation, you may only cancel a reservation by calling the pro shop, online cancellations are not permitted.
- **Membership Cancellation/Deferral.** In any case of members being unable to complete the season for which they have joined, payment refunds are not possible in any circumstances. Instead, the member may choose from one of the following options:
  - 1) Deferral to the following season. Apply the unused portion of their membership to the following golf season, and pay the difference between the unused portion and the membership rate for the following season. If the deferral takes place before the start of the golf season, the membership would transfer in full and a balance would be owing on the membership transfer only if a rate increase would be subject for the following season.
  - 2) Apply the unused portion of their membership on other services (green fees, prepaid golf/cart packages) at the golf course. This must be arranged with the General Manager within 30 days of the date in question when the unused portion begins.
- **Code of Conduct:** Groupe Fortin reserves the right to revoke membership privileges, with no refund, at any time for any misuse of membership privileges or misconduct by any Manderley on the Green golf club member at any of our partner courses.
